

KEY TERMS AND CONDITIONS FOR ONLINE PAYMENTS

The following is a summary of the Key Terms and Conditions of Online Payments (“the Service”):

- Payment(s) through the Service may only be made with a credit card or debit card. We accept Visa, MasterCard, Discover and American Express cards through the Service. If you do not have one of these credit/debit cards, the Service will not accept your payment. Please contact P&R directly for further payment assistance at (303) 985-8787.
- Before using the Service, it is recommended that the User shall make necessary enquiry about the charges or fees payable against the credit/debit card used from her/his credit/debit card service provider, i.e. the respective Bank.
- The credit card information supplied at the time of using the Service is processed by the payment gateway of the service provider. It is the sole responsibility of the User of the Service to ensure that the information entered in the relevant fields is correct. It is recommended that the User take and retain a copy of the transaction for record keeping purposes, which might assist in resolution of any disputes that may arise out of usage of the Service.
- P&R and/or the Payment Service Providers shall not be liable for any inaccuracy, error or delay in, or omission of (a) any data, information or message, or (b) the transmission or delivery of any such data, information or message; or (c) any loss or damage arising from or occasioned by any such inaccuracy, error, delay or omission, non-performance or interruption in any such data, information or message. Under no circumstances shall P&R and/or the Payment Service Providers, its employees, directors, and its third party agents involved in processing, delivering or managing the Service, be liable for any direct, indirect, incidental, special or consequential damages, or any damages whatsoever, including punitive or exemplary arising out of or in any way connected with the provision of or any inadequacy or deficiency in the provision of the Service or resulting from unauthorized access or alteration of transmissions of data or arising from suspension or termination of the Service.
- The User agrees that P&R or any of its employees will not be held liable by the User for any loss or damages arising from the User’s use of, or reliance upon the information contained on the Website, or any failure to comply with these Terms and Conditions For Online Payments where such failure is due to circumstance beyond P&R’s reasonable control.

Debit/Credit Card, Bank Account Details:

- The User agrees that the credit/debit card details provided by her/him for use of the aforesaid Service(s) must be correct and accurate and that the User shall not use a credit/debit card that is not lawfully owned by her/him or the use of which is not authorized by the lawful owner thereof. The User further agrees and undertakes to provide correct and valid credit/debit card details.
- The User may pay her/his legal fees and costs to P&R by using a credit/debit card. The User warrants, agrees and confirms that when she/he initiates a payment transaction and/or issues an online payment instruction and provides her/his credit/debit card: the User is fully and lawfully entitled to use such credit/debit card for such transactions; the User is responsible to ensure that the credit/debit card details provided by her/him are accurate; the User authorizes debit of the nominated credit/debit card for the Payment of fees and costs selected by such User along with any applicable fees. The User is responsible to ensure that sufficient credit is available on the nominated credit/debit card/bank account at the time of making the payment to permit the Payment of the fees and/or costs payable selected by the User inclusive of any applicable fees.
